- 5) New Business
  - Operating Procedures yearly AGM date set to September
  - Council of School Councils Meeting Darla and Shallen attended (virtual) meeting of all parent councils in division. Each council had a few minutes to report on school highlights and issues, as well hear discussion around division COVID protocol, cutback concerns, pandemic expenses, legal/lawsuit concerns.
  - Sturgeon Public School / RQB Ag Society Arena/Gym Ownership Agreement: Parents are concerned that students will lose access to arena and other opportunities (with having access to 2 gyms) if agreement is not reached. Another concern is the expense of these negotiations if legal intervention is needed. Mary Lynne Campbell has offered to meet with Shallen and Darla to discuss.   - 2021/2022 Division Calendar any feedback from parents on proposed dates?
     Suggestions regarding a longer fall (November) break as well as a Nov 1st PD day (as Oct 31 Halloween falls on a Sunday). Dan/Joe to take recommendations back to central administration.
  - Christmas Hamper/Adopt a Family Dan is working with teachers/classes to sponsor 5 local families in need with a Food/Gift basket. Each class will ask for contributions to the hampers. CSC discussed and Kelly made a motion that CSC provide a donation for each gift basket of \$50 (\$250 total) for a ham or turkey in form of item or gift card, as well as to fill in any gaps if not received through student donations (not exceeding an additional \$250). Amber seconded. Darla to request funds from CSSA.
- 6) Principal Report
  - Another covid case this week. Protocols working and being followed. AHS lets admin know when they can communicate further information to parents. Dan asked for feedback - parents are good with covid communications to date.
  - Budget quarterly report shared expenditures total about 11% for about 20% of the year so far.
  - Construction continues on new school. RFP for new playground closes Nov 30th.
  - Parent asked about assistance for younger grade teachers having difficulties with teaching through masks - wondering if plexiglass barrier could be a solution? Dan will ask teachers if that is something they are interested in. Joe will find out if more clear masks are available for teachers.
  - Parent asked about stage in new gym? Dan said a stage has been purchased for the new gymnasium.
